VISA REQUIREMENTS FOR THE KINGDOM OF SWAZILAND

PASSPORTS:

All visitors require valid passports or travel documents. The visitors are required by law to report to an Immigration Office or Police Station within 48 hours of their arrival unless they obtain accommodation on the night of arrival on premises for which a hotelkeeper is responsible and have completed appropriate forms. Visitors who intend staying for more than 60 days must apply for a Temporary Resident Permit from:

VISAS:

All visitors require visa to enter Swaziland except for nationals of the Commonwealth countries:
(with the exception of INDIA, SRI LANKA, NIGERIA AND BANGLADESH)

Visas are issued by Swaziland Missions and consulates abroad and in Swaziland by the Chief Immigration Officer at the above-mentioned address. In countries where Swaziland has no Missions or Consulates, this service may be rendered by the British Consular Officials.

Visa application forms, together with two passport size photographs of the applicant and his/her passport, must be completed in duplicate and mailed to:

Applicants residing within the Washington Metropolitan Area are urged to submit their applications in person. Please allow at least 24 hours to process the visa.

Visitors coming through South Africa with passports other than South African passports may require a re-entry visa or permit for returning to the Republic of South Africa. Applications should be made to the South African Authorities before departure.

FEES:

Single Entry	3 months	= US \$10.00
Multiple Entry	3 months	= US \$40.00
Multiple Entry	6 months	= US \$90.00

HEALTH:

Swaziland does not require smallpox vaccination certificate from people visiting Swaziland

Travelers who have come from an endemic Yellow Fever area are advised to have valid inoculation certificates on entry into Swaziland. Swaziland and South Africa are not in the endemic zone.

Malaria, which used to be a serious health problem, has now been largely controlled. Nevertheless, those who intend spending time in the lowveld, particularly fishermen visiting low-lying rivers, are advised to take simple anti-malaria precautions. Anti-malaria tablets are available from government hospitals, health centers and clinics, or from any chemist.

Bilharzia, although controlled in certain areas, is a major health hazard and it is unwise to bathe in any river, stream or dam in Swaziland.

Swaziland requires that all travellers visiting the Kingdom from countries where cholera cases had been reported should be in possession of a valid cholera vaccination certificate.

Persons visiting Swaziland without prior vaccination against Yellow Fever or Cholera will be expected to undergo vaccination at any of the Kingdom's Public Health Units, subject to a minimal charge. Vaccinations are obtainable from Public Health Units on Fridays and Wednesday from 9:00 a.m. to 4:30 p.m. and on Mondays and Thursdays from 2:00 p.m. to 4:30 p.m
